# Real Estate Salesperson (RES) Course

From 22 October 2010 onwards, one of the registration criteria for entry into the Real Estate industry is to pass the CEA mandatory examination or possess equivalent qualifications. Prior to taking the examination, applicants will be required to complete a preparatory course conducted by a CEA Approved Course Provider (ACP).

RES Course is a *compulsory course* that new Real Estate entrants must undergo before taking the industry RES Examination.

The RES Course is composed of four (4) Competency Units:

Competency Unit 1:  Real Estate Agency Industry Overview (including Estate Agents Act and regulation of real estate industry)	Competency Unit 3: Real Estate Marketing
Competency Unit 2: Basic Land Law Concepts and Dealings with Interests in Land	Competency Unit 4:  Property Transactions - Laws and  Practices  (including sale and lease of HDB and  private properties)

# **RES Course Requirements**

Candidates must bring the following documents during RES Course Registration:

- Photocopy of NRIC (front and back)
- Original Academic Certificates
  - Minimum educational requirement of at least 4 GCE "O" Level passes or equivalent
  - Candidates are required to show the original certificate/s to the course provider during course registration
- Email Approval from CEA
  - Only applicable to registrants who submitted a Foreign or Private certificate

### **RES Course Eligibility** II. Workplace Literacy and Numeracy -**WPLN** Assessment

- Applicants who do not possess at least 4 GCE 'O' Level passes may take the Workplace Literacy and Numeracy (WPLN) assessment
- Applicants who have attained Level 5 and above for the WPLN assessment in these 5 components will be recognised in lieu of 4 GCE "O" level passes:
  - 1. Reading
  - 2. Writing
  - 3. Listening
  - 4. Speaking
  - 5. Numeracy


# RES Course Eligibility III. Foreign or Private Academic Certificates

- Applicants without Singapore Local certificates are required to submit their Foreign or Private certs to CEA for Verification prior to RES Course Registration
- Required documents:
  - Original Certificate of Graduation
  - Original Transcript of Records
  - Filled out CEA Request Form
  - English Translation of certificates (if necessary)
- Cut off time: \*Friday, 6:30PM
  \*If Public Holiday falls on a Friday, cut off time will be Thursday at 6:30PM
- **❖ Submission to CEA:** Tuesday of the following week
- Processing Time: 15 working days (from submission date to CEA)
- CEA Admin Fee: \$64.20 (only payable in CASH)

# RES Course Eligibility IV. Foreign Applicants: NOT Singaporeans and Singapore PR

- ❖ A Letter of Support (LOS) from the preferred Estate Agency is required
- ❖ The LOS serves as a proof that the Agency will aid the applicant to have a valid Employment Pass (EP) issued by the Ministry of Manpower (MOM) once employed by the estate agency as one of its RES.
- ❖ If the foreigner will not be taking the RES Exam, and will attend the course for knowledge purposes only, the LOS will no longer be required. However, the RES Course Certificate will NOT be issued to this trainee. A Letter of Understanding needs to be signed informing the applicant of the Terms & Conditions.

- 1. The RES examination commences at 9.30am. Candidates are reminded to be punctual. Candidates who arrive at the exam registration counter after the 15 minutes grace period (i.e. 9.45am) will NOT be allowed to sit for the examination. No refund of the examination fee will be given to the candidates.
- Candidates are not allowed to carry their mobile devices during the examination. All mobile devices
  must be switched off (No vibration or airplane mode is allowed) and placed at the designated area in
  the examination hall. Any candidate found to be in possession of their mobile devices during the
  examination may be disqualified from the examination and/or barred from taking future
  examinations.
- 3. All copies of the questions and examination papers are the property of CEA and must be returned to the invigilator at the end of the examination. Recording of the examination questions in any form is strictly prohibited. Any candidate who is found to have recorded the examination question and/or leaves the examination hall with the examination paper will be immediately disqualified from the examination and reported to CEA. - 3. The appeal outcome will be sent via email within **14 working days** after the appeal submission closing date. Candidates will not be shown their answer scripts.
- 4. An administrative fee of \$64.20 (incl. GST) per paper per transaction will be levied.


